David Shestokas video regarding Court Procedures and Rulings

Hello David,

This video, https://youtu.be/j1xldIBa_Cl, highlights many of the constitutional problems associated with my case, but with one major variation, my actions never constituted a crime. They used a fatally flawed indictment to pressure and intimidate me to accept a plea agreement to a crime that does not exist under the Statutes and Regulations of the FDA. The Judge and Probation Office then maxed my time of incarceration and made me serve my full sentence thru the rules of procedure, which they deceptively enforced during my Motion to Vacate to the 5th Circuit Court of Appeals and still do regarding my supervised release. So even though I proved my innocence while in prison, I still had to serve my full sentence because of phony procedural violations. Now after Feb 14, 2023, when my Supervised Release is complete, I can file a Writ of Coram Nobis and overturn my conviction. The whole process started in 2010 when 60 Minutes produced a Slander with Malice Investigative Report against me and the Stowe Foundation. That gave the FDA and the DOJ an excuse to start a criminal investigation which led to a federal indictment for a Crime that does not legally exist by Law or Statute.

My public defender refused to argue this or even let me know the facts of the Law and pressured me to sign a plea agreement as an innocent man. I had to make these arguments from inside prison as an Ineffective Assistance of Council Motion, (a violation of the 6th Amendment) coupled with lack of due process by the DOJ and FDA (violation of the 5th Amendment). I was about to be released when the district Court claimed I missed a filing by one day and hence was time barred in my appeal. The time bar was based on a Court Order that I never received, to which my Warden testified. I only knew to file a response because my brother went on [Pacer.gov](https://www.pacer.gov) and sent me a copy.

The delay in getting a copy of the Court Order caused me to miss the formal filing deadline for my response. The 5th Circuit dismissed my Appeal based on the rules and told me my options. File a Writ of Coram Nobis upon completion of my sentence to overturn my conviction or appeal the Time Barr ruling to the Supreme Court. I was only 4 months from my release from incarceration and being sent home to start 3 years of Supervised Release. For any normal prisoner, 3 years of Supervised Release is reduced to 1 year, maybe 18 months. But in my case the Judge has elected to make me serve the full 3 years of Supervised Release.

The QC Times did a hit piece on me August 9, 2022 to try to get the Judge to send me back to prison. So, I am glad you posted this video because disputes with the Regulatory Agencies are 99% Civil matters that the Deep State turns into Criminal cases to lock up their political
